ORDINANCE NO. 17

AN ORDINANCE PROHIBITING EXOTIC, VICIOUS AND UNCONTROLLABLE ANIMALS IN THE VILLAGE OF PLEAK (DEFINED IN SECTIONS).

INCLUDING BUT NOT LIMITED TO ANIMALS OUTLINED IN SECTION I.

BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE VILLAGE OF PLEAK, FORT BEND COUNTY, TEXAS:

SECTION I: EXCEPT AS OTHERWISE PROVIDED HEREIN NO PERSON OR PERSONS SHALL CAGE, HOUSE OR CHAIN ANY OF SAID ANIMALS:

I. TIGER
II. LEOPARD
III. LION
IV. BEAR

V. PANTHER (BLACK)

VI. ELEPHANT VII. BABOON VIII. PYTHON

IX. WILD HORSES
X. WILD BOAR

XI. TRAINED KILLER DOG

XII. GORILLA XIII. COUGAR XIV. JAGUAR

SECTION II: THE PROVISIONS OF SECTION I OF THIS ORDINANCE SHALL NOT APPLY TO ANY SMALL DONESTIC OR HOUSEHOLD PETS

WHEREAS: THE LAWS OF THE STATE OF TEXAS HAVE PLACED VARIOUS REQUIREMENTS ON MUNICIPALITIES REGARDING THE SAFETY OF ALL PEOPLE

WHEREAS: THE VILLAGE OF PLEAK AND ITS GOVERNMENTAL
STAFF MUST TAKE CERTAIN PRECAUTIONS TO COMPLY
WITH THIS LAW

WHEREAS: THE VILLAGE OF PLEAK, TEXAS, HAS HERETOFORE, THROUGH ITS DULY AUTHORIZED GOVERNING BODY, APPROVED AN AGREEMENT TO EXECUTATE A FINE OF ONE HUNDRED PER DAY FOR ANY PERSON OR PERSONS NOT COMPLYING WITH SAID ORDINANCE

WHEREAS: THE VILLAGE OF PLEAK, TEXAS, WILL SUBMIT ALL
OFFENDERS TO THE FORT BEND COUNTY SHERIFF
DEPARTMENT

THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE, APPROVAL AND ADOPTION.
