

VILLAGE OF PLEAK REGULAR COUNCIL MEETING MARCH 20, 2019 MINUTES

The Board of Aldermen of the Village of Pleak, Texas met in Regular Session, open to the public, on February 20, 2019 at 7:00 p.m. in the Pleak Village Hall located at 6621 FM 2218 South, Richmond, Texas.
