

## VILLAGE OF PLEAK REGULAR COUNCIL MEETING APRIL 15, 2020 MINUTES

The Board of Aldermen of the Village of Pleak, Texas met in Regular Session, open to the public, on April 15, 2020 at 7:00 p.m. in the Pleak Village Hall located at 6621 FM 2218 South, Richmond, Texas.
