The Board of Aldermen of the Village of Pleak, Texas met in Regular Session, open to the public, on May 20, 2020 at 7:00 p.m. in the Pleak Village Hall located at 6621 FM 2218 South, Richmond, Texas. A Village of Pleak City Council Workshop was set for June 3, 2020.


9. **Adjournment.**
