

VILLAGE OF PLEAK REGULAR COUNCIL MEETING JUNE 17, 2020 MINUTES

The Board of Aldermen of the Village of Pleak, Texas met in Regular Session, open to the public, on June 17, 2020 at 7:00 p.m. in the Pleak Village Hall located at 6621 FM 2218 South, Richmond, Texas. Council members present Michael John, Wade Goates, Damon Kuhn, Carolyn Delmar, and Anne Stark. Mayor Pro-Tem Michael John opened the meeting with a prayer and the Pledge of Allegiance.
