**The Board of Aldermen of the Village of Pleak, Texas met in Regular Session, open to the public, on December 16, 2020 at 7:00 p.m. in the Pleak Village Hall located at 6621 FM 2218 South, Richmond, Texas. Council members present Mayor Larry Bittner, Michael John, Wade Goates, Carolyn Delmar, and Anne Stark. Mayor Larry Bittner opened the meeting with a prayer and the Pledge of Allegiance.**

- 1. Council to approve or correct the minutes as presented from the November 18, 2020 Budget Public Hearing and City Council Meeting.**
