

VILLAGE OF PLEAK SPECIAL COUNCIL MEETING MARCH 3, 2021 MINUTES

The Board of Aldermen of the Village of Pleak, Texas met in Special Session, open to the public, on March 3, 2021 at 7:00 p.m. in the Pleak Village Hall located at 6621 FM 2218 South, Richmond, Texas. Council members present Mayor Larry Bittner, Alderman's Michael John, Wade Goates & Anne Stark. Mayor Larry Bittner opened the meeting with a prayer and the Pledge of Allegiance.

1. Council to discuss and take action on a sign variance request from Ty Coburn with the 36 Business Park.

Michael John made the motion to postpone the request until a future meeting when Mr. Coburn could be present and to get more information. Wade Goates made the second and the vote was unanimous.
