



**VILLAGE OF PLEAK
REGULAR COUNCIL MEETING
JULY 21, 2021
MINUTES**

The Board of Aldermen of the Village of Pleak, Texas met in Regular Session, open to the public, on July 21, 2021, at 7:00 p.m. in the Pleak Village Hall located at 6621 FM 2218 South, Richmond, Texas. Council members present Mayor Larry Bittner, Michael John, Wade Goates and Sophia Rico. Mayor Larry Bittner opened the meeting with a prayer and the Pledge of Allegiance.

- (1) Council to discuss and take action on an Ordinance of the Village of Pleak, Texas to reduce the Village of Pleak's extraterritorial jurisdiction on request of landowners of the territory; and repeal Ordinance no. 19-91.**

No workshop was set for August 2021.


(9) Adjournment.
