

RESOLUTION NO. 23 – 123

A RESOLUTION OF THE VILLAGE COUNCIL FOR THE VILLAGE OF PLEAK, TEXAS, CANVASSING THE RETURNS OF THE SPECIAL ELECTION HELD IN THE VILLAGE OF PLEAK, TEXAS ON THE 6th DAY OF MAY 2023, FOR THE PURPOSE OF ELECTING FOUR (4) ALDERMAN-AT-LARGE AND ON A PROPOSITION FOR THE REAUTHORIZATION OF A LOCAL SALES AND USE TAX IN THE VILLAGE OF PLEAK AT THE RATE OF .25%.

WHEREAS, the Village Council of the Village of Pleak certified on March 15, 2023, that no candidates had opposing candidates; and

WHEREAS, the Village Council of the Village of Pleak tabulated the number of votes for the Special Election Proposition and after the reading of the tabulation of votes has accepted the tabulation of votes as correct.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF PLEAK, TEXAS:

That the Village Council of the Village of Pleak previously certified, on March 15, 2023, that no candidates had opposing candidates. Therefore, the following candidates are deemed duly elected:

General Election:

Michael John	Alderman-at-large
Wade Goates	Alderman-at-large
Wayne Kelley	Alderman-at-large
Alex Gutierrez	Alderman-at-large

Special Election:

That the Village Council of the Village of Pleak finds and determines that a special election was duly held in the Village of Pleak in accordance with the provisions of the Texas Election Code on Saturday, the 6th day of May, 2023, at which election a certain proposition was considered, to-wit, Proposition A, that notice thereof was given in accordance with law; the due returns of said election have been made by the proper officers and canvassed by the Village Council of the Village of Pleak; that said election in all things complies with the Texas Election Code; and that at said election, the following votes were cast:

PROPOSITION A


The reauthorization of a local sales and use tax in The Village of Pleak at the rate of .25% to continue providing revenue for maintenance and repair of municipal streets. The tax expires on the fourth anniversary of the date of this election unless the imposition of the tax is reauthorized.

Against: 3


